Terms of Sales - Warranty

General Information

All prices shown on GKM Consultants proposal exclude shipping cost unless otherwise stated and are for merchandise packaged for shipment by domestic carriers within the continental limits of North America. Special packaging for export air or sea freights are extra-charged items. Freight charges can be prepaid by GKM Consultants Inc. and charges invoiced to the purchaser. For specific incoterms, see detailed information on the proposal.

Terms

Domestic shipments are payable: net 30 days. (First order: payment in advance at time of order)

A monthly service charge of 1.5% (18% APR) will be added on all past due balances.

Export shipments will be made only:

- 1) After receipt of irrevocable letter of credit.
- 2) Or by payment in advance.
- 3) Or by special prior arrangement with GKM Consultants Inc.

Quotations

All GKM Consultants Inc. quotations are firm for 30 days. Thereafter, they are subject to change without notice.

Errors, Shortages, Complaints

All shipments should be opened immediately on delivery and the contents checked against the packing list sent with the shipment.

GKM Consultants Inc. exercises due care to avoid errors and shortages. However, where errors and shortages do occur, they should be reported within 10 days of receipt of the equipment. Where errors are the fault of GKM Consultants Inc., they will be rectified without delay.

Responsibility and Risk

GKM Consultants Inc.'s responsibility for merchandise damaged in transit ceases when the merchandise has been delivered to the carrier for shipment and a valid receipt obtained. Claims for damage in transit are to be made with the carrier, and damaged containers or other evidence of rough handling should be noted at the time of receipt, and the containers retained until the claim is resolved.

Delay Damages

Client agrees to hold harmless GKM Consultants from liability or responsibility for any delay damages, or time-related penalties arising from the work, including, but not limited to, liquidated damages, direct damages, indirect damages, consequential damages, acceleration, overtime, extended overhead, and other delays related damages.

Returned Merchandise

Equipment is not to be returned without first contacting GKM Consultants Inc. and obtaining its consent. All approved returns must be packaged to prevent damage, insured, and returned prepaid. Returned standard equipment is subject to a restocking fee of at least 25%. For custom-built equipment for which return has been authorized, restocking fee will be determined on a case-by-case basis.

Field Services

Field services to train client's personnel in assembly, installation and operation of the instruments is available.

The daily rate (minimum 8 hours/day) is as per the proposal or quotation, or part thereof, will be charged as follows:

- 1) Time required for travelling from GKM Consultants office to the job site and return.
- 2) Time required for working on the job.
- 3) Standby time at the job site.
- 4) Time required for travelling between accommodation and job site in excess of 30 minutes each way.
- 5) Travel and living expenses charged as presented in quotation, or at cost plus 15% if not specified.
- 6) When mobilization expenses include airfare, expenses can be revised if airfare cost varies by more than 10%.
- 7) For work performed during statutory holiday, a 50% premium on hourly rate will apply.
- 8) For work performed above 10 hours a day or during a night shift, a 50% premium on hourly rate will apply.
- 9) The costs associated with preventive measures, testing and repercussion of COVID-19 are the client's responsibilities from the beginning till the end of the mandate, for example, but not limited to costs of screening, additional mobilization, and demobilization, standby and/or quarantine time, which will be invoiced according to the normal working hours on-site.
- 10) Cancellation of a mission: The cancellation, including schedule changes or postponement of a mission must be notified in writing (email) at least 5 days before mobilization.

Cancellation Fees:

- 1) Any non-refundable transportation costs (airplane, renting vehicles or others) will be charged at cost + 15%.
- 2) Any non-refundable accommodation costs (hotel or others) will be charged at cost + 15%.
- 3) If the cancellation is notified less than 5 days in advance, the above conditions apply, and an additional fee of 5 hours of project management will be charged.
- 4) No cancellation fees will be charged in cases of Force Majeure (natural disasters, conflicts, etc.).

Repairs

All items returned for repair, both warranty and non-warranty, must have an officially issued Return Material Authorization (RMA) number. Please contact GKM Consultants Inc. directly for more information and to initiate the Return Authorization process. The hourly rate for non-warranty repair is as per the proposal or quotation. Non-warranty repair should be accompanied by a purchase order to authorize the work. GKM Consultants Inc. will not accept, nor work on, returns that are lacking.

All returns for repair must be sent with shipping prepaid. All repairs are subject to the terms and conditions of the following warranty statement.

Warranty Statement

If the unit should malfunction, it must be returned to the factory for evaluation.
